Suppliers will be allowed to register for a maximum of 3 services / commodities. The following documents must be attached to each application:

- Valid **Original** Tax Clearance Certificate
- Certificate of incorporation from the Registrar of Companies (CIPRO)
- Brief Company Profile, organogram and brochures
- Proof of accreditation / registration / dealerships / affiliation to relevant professional institutions or regulatory councils relevant to the type of service or commodity (e.g. CIDB)
- Certified copies of ID document of company member(s) (ownership)
- Cancelled cheque
- Certified copy of water and lights account
- VAT Registration

The application forms are free of charge.
Suppliers should take note of the special conditions indicated in the application forms in order to ensure successful registration.
